Subject: - Right to Free and Compulsory Education of 6-14 Years of Children Rules, 2011 and sub-rule (4) for the purpose of section 18 regarding renewal/issuance of recognition to the Free and Compulsory Education of Children Act, 2009.

Sir,

In response to the request received by you and subsequent correspondence/inquiry in this regard, the undersigned hereby issues/renew the recognition of the following schools for Class I to Class VIII up to 31-03-2023.

This approval will be considered valid only after the fulfillment of the following conditions.

Conditions:-

The time for sanction of recognition cannot be extended and in any case does not guarantee recognition/affiliation beyond class VIII.

The school shall comply with the Right of Children to Free and Compulsory Education Act 2009 (Annexure 1) and the Children's Compulsory and Free Education Rules 2011 (Annexure 2) respectively.

The school will enroll in the first class and provide free and compulsory education up to the completion of elementary education to 25 percent of the class to all students from the weaker sections and disadvantaged sections of their neighbourhood. Provided that this rule will also apply to pre-primary classes

For the students referred to in paragraph No. 3, the school shall make the payment as per sub-section 2 of section 12 of the Act and provide a separate bank account for the payment thereof.

The school will not collect any compulsory fee from any parent or guardian for any action.

The school will not entertain any person for admission:-

- (for admission) if admission is granted.
- iii. Based on religion, caste, place of birth or other reasons

The school will ensure.

- i. No intervention student can be stopped or expelled in any category until his elementary education is completed.
- ii. No physical or mental punishment will be given to any student.
- iii. No student will be required to pass any board examination before completing elementary education
- iv. According to Rule 21, every student will be awarded a certificate after completing elementary education.
- v. Students with disabilities, disabilities or special needs will be admitted under the law.
- vi. A teacher appointed as per sub-section (1) of section 23 should fulfill his educational qualifications. If already employed they shall complete their required minimum educational qualifications within 5 years from the date of commencement of the Act.
- vii. The Teachers shall perform their duties under the rules laid down in section 24 and sub-section (1) of the Education Act.
- viii. Teachers will not involve themselves in any form of private tuition.
- ix. The school will follow the timetable and schedule distribution as prescribed by the competent governing body/authority.

The school shall admit children according to the ratio specified in section 19 of the Act.

The school shall follow the norms as per Section 19 of the Right to Education Act. The facilities shown as per previous inspection, if any, are as follows: -

The area of the playground

Number of classrooms

Head teacher cum officer cum storage room

Availability of reading material Sports equipment/library material.
No unrecognized class will be taught inside or outside the school premises other than this school.

The school building and structure or playground shall be used only and exclusively for the educational activities and skill development of the school.

A school being run by a society registered under (Act No: 21 of 1860) Act or being run by any public institution for a period of time.

The school should not be run for the benefit of any individual class or individual group.

The accounts of the school should be audited by a Chartered Accountant/CA and a table of accounts should be prepared as per rules. Every year table download will be sent to the District
