

2. After thoroughly considering the documents submitted by management of the school including Affidavit, recommendation of Distt. Education Officer (S.S) Gurdaspur and Director Education Department (S.S) Punjab, Chandigarh, the requisite No Objection Certificate is given by the Punjab Govt. on following conditions:-

1. In future on any complaint/inspection, if this fact came forward that at the time of taking No Objection Certificate application has been given on the basis of wrong information and instructions issued by the Punjab Govt. from time to time are not complied with and in this case written conditions mentioned in the affidavit are not obeyed, then in such circumstances this No. Objection Certificate can be withdrawn any time.

2. Teaching of Punjabi upto matric standard in Your school will be compulsory and CBSE New Delhi shall make arrangement for getting examination of Punjabi in such schools, and it is also stated that in case of not doing so, No. Objection Certificate will be withdrawn immediately.

3. The school management shall implement rules issued under RTE Act 2009 notification and RTE Act 2009 of Punjab Govt. Department of Education in letter and spirit prepared for Punjab State.

That After obtaining affiliation of CBS New Delhi, management of the school shall be responsible for making payment pay and allowances etc. to teaching and non teaching staff of the school like Govt. employees through account payee cheques. In case of not doing so, No. Objection Certificate will be withdrawn immediately.

5. You yourself, and your management will ensure that education officer of your district or senior officer of Education Department whenever demands any type of information, the requisite information shall be provided to him and requisite co- operation shall also be rendered.

6. This No. Objection Certificate is issued to you on this condition that you will ensure production of Building Safety certificate and fire safety certificate of your school to this office within two months.
