issued subject to the following conditions :

1. If it is found in future that you have submitted the application
for no objection certificate on the false ground or / you did not
follow the instructions of the Punjab Govt. and you have not
obeyed the conditions given in the affidavit, the no objection
certificate will be cancelled.
2. It is mandatory for your school to make the arrangement of
teaching Punjabi language up to Class X level and that CBSE will
make necessary arrangements of conducting examinations of Punjabi
subject. In contravention of the above the no objection
certificate will be withdrawn immediately.
3. The management of the school will be bound to give salary to
the teaching and non-teaching staff like the Govt. employees
after getting affiliation to the CBSE. In contravention, the
no objection certificate will be withdrawn immediately.
4. You and your management will ensure to supply the necessary
information to the District Education Officer of your District
or any other senior officer of the Education Department as and
when desired and also ensure the necessary co-operation.

Dear Sir/Madam,

With reference to your application dated 31.7.2004 and subsequent correspondence with the school/inspection in this regard, I am directed to convey the Provisional/Composite Provisional Affiliation for Secondary School Examination Board for a period of three years w.e.f. 1.4.2006 to 31.3.2009

The above sanction is subject to the fulfillment of the following conditions:

1. The school will follow the national syllabus for the middle classes.
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
3. The school shall appoint only qualified and eligible staff.
4. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school and furniture at its disposal for holding its examinations free of charges if required.
5. The school will spare sufficient teachers, for invigilation purpose at the examination of the Board, as may be required.
6. The school will spare its teachers for evaluation of answer-books for the examinations, if required.
7. The school will provide Laboratories, Library and other facilities as per the requirements of the Board.
8. The school will abide itself by the conditions of affiliation already prescribed by the State Government concerned.
9. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
10. Service conditions, pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees of the Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.

11. The school and its records shall be opened for inspection by an officer of the Board or an authorised representative of the Board/State Educational Department any time and the school shall furnish information as may be asked by the Board/State Government from time to time.

- The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
- 13. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
- 14. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
- 15. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
- 16. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
- 17. The school should not start Class XI/XII without written approval of the Board. The Board shall not be responsible for any consequences in case class XI/XII is started without following the Affiliation Bye Laws and obtaining the prior approval of the Board.
- 18. The affiliation Code Number allotted to your school is 1630386. This may please be noted and quoted for any correspondence with the Board.
- 19. Annual fee @ Rs.1000/- per annum for three years be also remitted at an early date. In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.)
- 20. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee and other essential documents in the preceding year before the expiry of the date.
- 21. The school is also advised to implement Rule II, Sub-Clause (3) Bye -laws. It is required that all the affiliated schools will grant full waiver of fees (for school meal and transportation fees) from class VI onwards to each girl student who is the single child of her parents. You are also advised to furnish regular quarterly report to the Board in the enclosed prescribed proforma.
- 22. The Principal of the school is required to be placed on the prescribed scale of pay.
- 23. EPF scheme is required to be extended for all the staff members.
- 24. Other conditions are as per Annexure 'A' enclosed.


