## AFFIDAVIT

I, Bhupinder Singh Son of S. Ranjit Singh, (aged 45 years), resident of village Landeke (Moga) & authorized signatory of the Kalgidhar Trust, Baru Sahib (H.P), running the Akal Academy Dhanal Kalan (District Jalandhar) do hereby solemnly affirm and sincerely state as follows :

1. That the Kalgidhar Trust, Baru Sahib (H.P) is a registered Trust under the Indian Societies Registration Act, at Shimla Vide No. 189 dated 22-10-1982.
2. That the Kalgidhar Trust, Baru Sahib (H.P) is of Non-Proprietary Character.
3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the Institution is being and will be diverted to any individual in the Trust School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.

6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent / Manager of the school has individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
