2. On the perusing and scrutiny the documents alongwith affidavit and recommendations of the District Education Officer (Sec. Edu.), Jalandhar and Director, Education Department (Sec. Edu.), Punjab, Chandigarh the requisite no objection certificate is issued on the following terms and conditions:-

1. If any complaint or any fact is brought into the knowledge during inspection that you have moved an application to the government on wrong information and the directions issued by the Punjab government are not complied with by you and you do not abide by the terms and conditions contained in the affidavit, then in such circumstances this no objection certificate can be withdrawn at any time.

2. It will be compulsory to teach Punjabi upto matriculation level and also will ensure provision to take examination in Punjabi in such schools of C.B.S.E. New Delhi and it is also added here that if it is not done, this no objection certificate will be withdrawn.

3. The School Management will abide by the rules framed under R.T.E. Act, 2009 for the Punjab State and notification issued by


