In connection with aforesaid issue.

Considering meticulously the documents presented by school management along with affidavit, references of district education officer (Sr. Sec.), Punjab, Chandigarh. No objection certificate is granted on the terms given below.

- 1) In future in case of any complaint or inspection, if it is noticed that government is misinformed at the time of requesting for NOC and or there is any act of disobedience of timely regulation released by Punjab government and in such case, terms mentioned in affidavit are not taken into account, then, in such circumstances, at any time, NOC can be immediately withdrawn.
- 2) In your school, it will be compulsory to teach Punjabi till tenth grade and CBSE New Delhi will provide its assistance in organizing the examination of Punjabi in such schools for sure and it is also cleared that in case of failure to do the same, NOC will be immediately withdrawn.
- 3) School management will precisely conform to notification released by the education department, Punjab government under RTE act 2009 and RTE act 2009 rules framed for Punjab state.
- 4) It is expected that after being awarded the affiliation from CBSE, New Delhi, school management will treat teaching and non teaching staff like government employees and is committed to release salary through the account of payee cheques. In case of failure to do the same, NOC will be withdrawn.





- 5) You and your school management will ensure that if the educators of your district or any senior official of the education department claim for any kind of information, at the time, the sought information will be made and required assistance will also be provided.
- 6) This NOC is granted on this condition that you will ascertain the deposition of building safety certificate and fire safety certificate in office within two months.

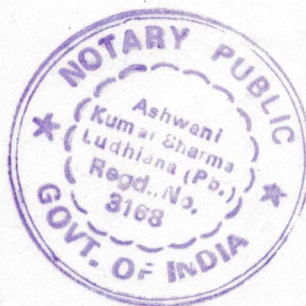
