Below written terms and conditions has been accepted:-

Conditions:-

1. The period of approval cannot be extended in any case there is no convenient for further approval after the eighth class.
2. The school shall strictly comply with right of children to free and compulsory Education act 2009 (annexure 1) and children to compulsory and free education rules 2011 annexure 2
3. The shall enrol in the first class and provide free and compulsory education up to the completion of elementary education to 25 per cent of the class to all students belonging to the poor and disadvantage section of the their neighbourhood will apply school.
4. For pupils referred to in Para No.3 as per sub section for section 12 for the Act shall apply and provide a separate bank account for the same.
5. The school will not collect any compulsory fee from any parent or guardian for any action.
6. The school will not refuse for any admission to:-
 - a. Any child who does not have a birth certificate or
 - b. If to admit such child during the specified or extended period.
 - c. If admitted on the basis of religion, caste, place of birth or any of these reasons.
7. School will be made on believe:-
 - a. No enrolled student shall be retained or referred to any class until his elementary education is completed.
 - b. No student shall be subjected to physical or mental punishment.
 - c. No any students have needed to pass Board Examination before completing elementary education.

- d. According to Rule 21 every student has provided the Certificate after completing elementary education.
- e. According to the law handicapped students and Basis needs students have given admission.
- f. According to section 23A Sub Section appointed teacher will completing their education qualification.
- g. If they are already appointed they shall complete their required minimum education qualification with 5 year from the date of coming into effect of the act.
- h. Teachers under the rules specified under section 24 and sub section of the education will perform their duties
- i. Teacher shall not engage themselves any form of private tuition. School capable authority institution follows the time table and curriculum distribution prepared by him.
- j. The school will admit children according to the ration specified in section 19 of the Act. The school shall maintain as per the norms as per Section 19 of the Right to Education Act the facilities provided as per previous inspection if any are as follows:
 - School Ground Area
 - Completed total Ground Area
 - Playing Ground Area
 - Room Section counting
 - Section Teacher cum officer cum Canteen room
 - Availability of Literacy Material Sports Equipment/Library.
- 11 Non -recognition class will not be taught in the name of that school inside or outside the school premises.
- 12 Structure of the school, the playground should be used only and only for the educational activities and skill development of the school.
- 13 According to law of School (1860 of law No.21) will be under register society or for some period running by any public society.
- 14 In the school itself, slip reads should not be conducted to benefit class or individual alliances.
- 15 The accounts of the schools will be completed by certified accountant /C.A and table should be according to law and every time table should be sending to education officer.
- 16 Your School recognized ID No. (RTE CODE /No.) Above showing list has been entered. Please note down it and in future due to explanation of letter this id number should be use.
- 17 All such reports and information shall be forwarded to the District Education officer or Director of Education Department by them from time to time. Such deficiencies will be rectified by the school and its report will be submitted result, it should be ensured that the capitalization of the organization is renewed.
- 18 It should be ensure that the registration of the institution has been revoked.
- 19 Other conditions have been attached according to annexure 3.

Note: This school is issued with this condition, it is said that every year, the school will get the certificated of safety and public health son-in-law and the department will arrange the time from the beginning of the given year to 30th April in the next 5 cases be given.
