Amritsar. Non-Submission of this will lead to be cancellation of recognition of school and strict action on school according to RTE Act & rules.
7. The school buildings or other structures or the grounds are used only for the purpose of education and skill development and No unrecognized classes shall run within the premises of the school or outside in the same name of school.
8. The teachers are recruited with minimum qualifications as laid under section 23(2) of the Act.
9. The school shall adhere the regulations by the Education department from time to time. Rest of the conditions will according to prior issued provisional certificate. The recognition Code Number allotted to your school is R.T.E. Amritsar-01980657.
10. The Management/School shall make sure to follow all terms and conditions given by the RTE Act 2009. If the Management/School has found to be failed to obey the any act/rules by the RTE Act or guidelines issued by concerned Department then recognition of the school should be cancelled.
