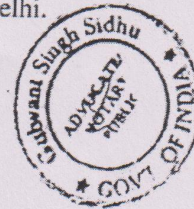

The required 10th level No objection certificate of the Punjab Government is issued on the following conditions:-

1. In case of any complaint/ Inspection in the future, It is comes to the fact that you have to give false information to the Government while obtaining No Objection Certificate. Application has been made on the basis and the instructions issued by the Punjab Government from time to time do not follow and by themselves do not comply with the written conditions provided with affidavit, so at any time, the No Objection Certificate will be returned. Can be taken.
2. Teaching Punjab in your school will be compulsory up to 10th level and C.B.S.E., New Delhi will make it an attempt to take Punjab examination in such schools and it is also said that this is not the case. In case of failure, the certificate of objection will be withdrawn immediately.
3. School Management Education Department, Punjab of Punjab, notification issued under R.T.I. Act 2009 and the R.T.I. made for the State of Punjab shall comply with the Rules of the Act 2009.
4. After receiving the affiliation of C.B.S.E. New Delhi the management of the school will be committed to providing the teaching staff and non-

- teaching staff of the school the same as government employees, through pay cheques. The school will submit reservation of Teaching and Non-Teaching Staff to the concerned District Education Office at the time of extension/up gradation as per the directions of the Government. In case of failure to do so, the objection certificate will be withdrawn immediately.
5. Your own management will also ensure that any information requested by your District's Education Department Officer will be provided with the required information as well as appropriate support. In case of failure to do so, the objection certificate will be withdrawn immediately.
  6. Child Safety, Public Health Sanitation and other objectionable certification requirements will be reviewed from time to time by inspection by Punjab Government officials.
  7. Letter No. 2/93/2009/3Edu.3/1360154 Dated 26-11-2018 of Government of Punjab the guidelines released through should be followed properly.
